- 2.5 Summitcrest Farms will pay you an allowance for food and meals and provide you with free accommodation whilst working at the Summitcrest Farms during the six month placement. The Sponsor will not be liable for any allowances not paid to you by Summitcrest Farms.

### **3. Your Obligations**

- 3.1 You must provide the Sponsor with a full medical certificate within 10 working days of receiving notification from the Sponsor that your application has been accepted.
- 3.2 You must follow all lawful instructions and directions given by Summitcrest Farms or the Sponsor during the term of the Scholarship.
- 3.3 You must not, either directly or indirectly, do anything to bring the Sponsor, the New Zealand Angus Association Incorporated or Summitcrest Farms into disrepute or ridicule and must behave in a proper manner befitting such a scholarship at all times.
- 3.4 You are liable to pay for any damage caused by you to any property owned or used by Summitcrest Farms through negligence or inappropriate behaviour or use.
- 3.5 You must provide your hosts at Summitcrest Farms with your contact details and keep in daily contact with them whilst in the United States of America during the six month placement.
- 3.6 You must keep your accommodation clean and tidy at all times.
- 3.7 All costs and expenses other than those set out at clause 2 above are to be met by you.
- 3.8 During the term of the Scholarship and for all promotional purposes you must wear the Sponsor's official clothing (such clothing to be provided by the Sponsor) when representing the Sponsor at any functions or bull sales or as otherwise directed by the Sponsor.
- 3.9 You must prepare and present to the Sponsor a project on any aspect of the Summitcrest Scholarship within three months of returning to New Zealand from the six month placement. A minimum of 4,000 words is required.
- 3.10 You agree to make yourself available if requested by the Sponsor to assist the Sponsor in promoting the Summitcrest Scholarship for the term of the Scholarship.

### **4. Termination**

- 4.1 The Sponsor may terminate this agreement immediately if you are in breach of any of the terms and conditions of this agreement. The Sponsor may give you notice of termination verbally, by facsimile or email.

4.2 You may terminate this agreement by giving the Sponsor written notice if you are required to return to New Zealand prior to the completion of the six month placement for personal reasons. Such reasons are to be stated in the written notice.

**5. Effect of Termination**

5.1 If this agreement is terminated by the Sponsor pursuant to clause 4.1:

- (a) the Sponsor may require you to immediately return to New Zealand; and
- (b) you will be liable to reimburse the Sponsor for all airfares and other travel related costs paid by the Sponsor pursuant to this agreement. In addition, you will be liable for all costs including, but not limited to, legal fees and disbursements incurred by the Sponsor to enforce its rights under this agreement.

5.2 If this agreement is terminated by you pursuant to clause 4.2 it will be at the Sponsor's sole discretion whether or not any reimbursement for airfares and other travel related costs paid by the Sponsor are to be reimbursed by you.
