**ESSENTIAL NATIONAL VIDEO SALE ENTRY CONDITIONS**

- All NAIT compliance is the responsibility of the vendor.
- Theileria Tick management – see National Video Sale Entry Conditions.
- All cattle must be TB tested and cleared within 12 months of the date of sale, with the exception of cattle from a movement control area which must have been tested and cleared within 60 days of the sale. TB test certificates must be lodged with the breed association, no later than the Friday prior to National Video Sale. This rule will be enforced without exception.
- Ear Tagging – all entries must display the mandatory NAIT/EID Breed tag requirements..
- No refunds will be issued after the 23rd March 2018 due to catalogue requirements.
- A proof of entry will be emailed for review as it will appear in the PGG Wrightshon Livestock National Video Sale catalogue.

**ANGUS ENTRY CONDITIONS**

- All bulls must have been DNA profiled, and been sire and Dam verified where possible.
- All animals must hold 'free status' (AMF, NHF, DD and CAF) for genetic defects Arthrogyposis Multiplex (AM), Neuropathic Hydrocephalus (NH), Developmental Duplication (DD) and Contractual Arachnodactyly (CA).
- No raw data will be displayed by ANGUS NZ on the day of sale.
- All animals must pass the inspection as approved by ANGUS NZ. NB. If more than one animal is being put forward for inspection to fill one lot then a separate entry form must be completed for each animal.
- All cattle must have been tested BVD Antigen negative and have been vaccinated twice within the last 12 months. The vendor must declare this in writing, accompanied by the vaccine batch number administered, with the breed association, no later than Friday 4th May 2018.
- Photos: all entries have the option of supplying quality colour photograph for use on the Angus NZ website.
