0-30 days	Current Account
	Interest will be charged at a rate of 2.00% per month from date of purchase The interest rate is reviewable by the Board
31-90 days	All office/registry processes are withheld until payment is received
91-120 days	A letter will be sent to each debtor giving seven days to pay and naming the date by which payment is required. If payment is still not forthcoming, Angus NZ reserves the right to recover the debt through an agency
121 days +	Recovery of the debt through an agency will be enforced.
